Dear Sir or Madam:

I am Assistant General Counsel of HarperCollins Publishers ("HarperCollins"), the publisher of the works listed on Schedule A hereto (the "Books") by Ray Bradbury ("Author"). As the exclusive publisher of the Books, HarperCollins has the sole right to publish, sell and otherwise distribute and display the Book in the English language throughout the world.

It has recently been brought to our attention that your web site located at [www.raybradbury.ru](http://www.raybradbury.ru) (the "Web Site") is publishing the text of the Books in their entirety and making them accessible to internet users located in the United States at the following web page:

In accordance with the Digital Millennium Copyright Act, we represent in good faith that neither HarperCollins, the Author, his Agent, nor any provision of law, has authorized the publication and display of the Books on the Web Site.

Please be advised that this unauthorized publication and distribution of the Book may violate HarperCollins and the Author's valuable rights under the Copyright Act of 1976, 17 U.S.C. sec. 101 et seq. (the "Copyright Act"), as well as the copyright laws of Russia, which acceded to the Berne Convention in 1995.


Accordingly, if the Book is not removed from the Web Site immediately, the Author and HarperCollins reserve their right to take all actions necessary to enforce and protect their valuable rights. We further demand that you provide us with written confirmation that the Book is removed from the Web Site within ten (10) days of the date of this letter.
